 - Pay dividend at rate 0.10 baht per share from the operation result of installment January 1 - December 31, 2014 to the shareholders amount 381,145,725 shares come to amount 38,114,572.50baht or 63.08% of net profit of Consolidated Financial Statements by separating into : pay from business of paid income tax 20% at rate 0.03 baht per share come to amount 11,434,371.75baht and pay from business of paid income tax 10% at rate 0.07 baht per share come to amount 26,680,200.75baht.
 - Rate of dividend payment in the year 2014 was at 63.08% decreased 23.92% when compared with dividend payment in the year 2013 that paid 87.00% but the rate of dividend payment in the year 2014 still higher than formulated dividend payment policy at 60% of net profit.
 - Dividend is deducted withholding tax 10%.
